- All, who wish to apply for New/Re-Issue of Machine Readable Passport (MRP) at the camp is requested to seek appointment by sending filled-in MRP form (3-pages in PDF format/scanned copy) at email [consular.canberra@mofa.gov.bd](mailto:consular.canberra@mofa.gov.bd). Last date of request for appointment is 15<sup>th</sup> April 2019. Mission will give appointment on first come first serve basis and applicant will be required to present at the camp premises with required documents on the appointment date and time.
